The Muscogee (Creek) Nation Department of Health (MCNDH) provides comprehensive health care services to Native Americans living within the Muscogee (Creek) Nation. MCNDH is an integrated system of six health centers, an Express Care Clinic, two hospitals, a physical rehabilitation center and nine comprehensive community health programs Offering services across the lifespan including pediatrics, family medicine, nursing, dental, laboratory, radiology, pharmacy, behavioral health, emergency medical, audiology, nutrition, physical therapy and optometry.

DESCRIPTION OF ASSIGNMENT: The incumbent is responsible for the coordinate the performance analysis, and design reports for use by clinicians and administration and develop and validate operational information for clinical departments. This position is located at the Muscogee (Creek) Nation Medical Center, located in Okmulgee, OK.

REQUIREMENTS: Candidates must meet the following requirements:

Bachelor's Degree in Statistical or Computer Science is required a Master's Degree is preferred. Four (4) years of relevant work experience is required. 2 years' experience in reporting, database or software development within a Healthcare environment is preferred. Incumbent must be insurable and valid Oklahoma Driver's License is required. Microsoft Certified Technical Specialist or Microsoft Certified Information Technology Professional certifications are a plus.

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities and personal characteristics, (KSAP's) required of this position. 3. Ability to work independently under minimum supervision.
4. Ability to communicate efficiently and effectively with department staff, tribal agencies, outside agencies and the general public both orally and in writing.
5. Ability to maintain a confident and professional demeanor.
