The Muscogee (Creek) Nation Department of Health (MCNDH) provides comprehensive health care services to Native Americans living within the Muscogee (Creek) Nation. MCNDH is an integrated system of six health centers, an Express Care Clinic, two hospitals, a physical rehabilitation center and nine comprehensive community health programs Offering services across the lifespan including pediatrics, family medicine, nursing, dental, laboratory, radiology, pharmacy, behavioral health, emergency medical, audiology, nutrition, physical therapy and optometry.

DESCRIPTION OF ASSIGNMENT: Under general supervision performs advanced nonprofessional nursing work involving a variety of bedside duties in a hospital and skilled nursing setting. Position is to provide services to the Muscogee (Creek) Nation Department of Health. Position is located at the Muscogee (Creek) Nation Physical Rehabilitation Center located in Okmulgee, OK.

REQUIREMENTS: Candidates must meet the following requirements:

High School Diploma or GED equivalent Long-Term Care Nurse Aide licensed by the State of Oklahoma and current CPR certification.

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities and personal characteristics, (KSAP's) required of this position. Applicants should address the following KSAP's on a separate attachment to their application.

1. Knowledge of basic medical terminology used in a health care facility.
2. Ability to interact professionally with healthcare practitioners and patients.
3. Knowledge of procedures for appointing and routing patients in a health practice setting.
4. Skills in organizing maintaining accurate records and documentation.
5. Ability to maintain strict confidentiality.
6. Ability to communicate courteously and effectively with patients, clinic/hospital staff, and the general public.
7. Ability to learn the requisition procedures, formats and protocols.
8. Ability to utilize a personal computer and its application in a Windows environment.
9. Ability to maintain a confident, professional demeanor.
