DESCRIPTION OF ASSIGNMENT: The primary purpose of the position is to perform mammographic examinations according to current standards of care and also perform certain routine radiological examinations as described in the Radiology Department Policies and Procedures. Incumbent is under the direct supervision of the Radiology Technologist Supervisor. Position is located at the Council Oak Comprehensive Healthcare in Tulsa, OK.

REQUIREMENTS: Candidates must meet the following requirements:

Completion of a formal radiological program from an accredited college or hospital base program. Mammogram certification is required. (Refer to Licenses & Certifications below for certification criteria). One (1) year relevant experience in radiology under the direct supervision of a registered radiology technologist. Current registration with the ARRT as a Radiologic Technologist is required. Certification in Mammography is required or be able to obtain Mammography certification within sixty (60) days of hire date. CPR certification is required. It is the policy of MCNDH for all employees to comply with the COVID-19 vaccination program.

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities and personal characteristics, (KSAP's) required of this position. <u>Applicants should address the following KSAP's on a separate attachment to their application.</u>

- 1. Knowledge of the physics of Radiology, such as kilo voltage, miliampres and time.
- 2. Knowledge of anatomy and physiology, positioning and compression relevant to mammography examinations.
- 3. Knowledge of methods, techniques and quality control required for processing mammograms with optimum results.
- 4. Skill in obtaining diagnostic quality images on patients for which normal techniques and methods are not possible, requiring techniques which deviate from the normal.
- 5. Ability to perform screening and diagnostic mammography exams.
- 6. Skill in producing radiographs in a dark room.
- 7. Ability to perform mammographic/radiological examinations in a variety of conditions; such as emergency trauma and also have the ability to handle patients in trauma.
- 8. Ability to communicate courteously and effectively to patients, other staff and the general public both orally and in writing.
