The Muscogee (Creek) Nation Department of Health (MCNDH) provides comprehensive health care services to Native Americans living within the Muscogee (Creek) Nation. MCNDH is an integrated system of six health centers, an Express Care Clinic, two hospitals, a physical rehabilitation center and nine comprehensive community health programs Offering services across the lifespan including pediatrics, family medicine, nursing, dental, laboratory, radiology, pharmacy, behavioral health, emergency medical, audiology, nutrition, physical therapy and optometry.

DESCRIPTION OF ASSIGNMENT: The purpose of this position is to perform the duties of a Therapist and Human Services Professional for the Behavioral Health Services Program. Incumbent provides services within the designated service are of the Muscogee Creek Nation Department of Health. Incumbent reports directly to the SBIRT Project Director. This position is located at the Sapulpa Indian Health Center located in Sapulpa, OK.

REQUIREMENTS: Candidates must meet the following requirements:

Level 1 Master's Degree in Counseling Psychology or related field and licensed or licensed eligible as an LCSW, LPC, LMFT, or LADC-MH is required.

<u>Licenses & Certifications-</u>LCSW, LPC, LMFT, or LADC_MH licensure valid in the state of Oklahoma is required.

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities and personal characteristics, (KSAP's) required of this position. - 2. Proven skill and ability in the areas of treatment, prevention, assessment, diagnostics and consultation.
- 3. Ability to follow BHS guidelines and established Muscogee (Creek) Nation Department of Health (MCNDH) policies and procedures.
- 4. Ability to courteously and effectively communicate with patients and their families, MCNDH staff, outside agencies and the general public both orally and in writing.
- 5. Ability to maintain strict confidentiality.
- 6. Ability to maintain a professional demeanor.
- 7. Knowledge of psychotherapeutic/behavioral intervention techniques.
