The Muscogee (Creek) Nation Department of Health (MCNDH) provides comprehensive health care services to Native Americans living within the Muscogee (Creek) Nation. MCNDH is an integrated system of six health centers, an Express Care Clinic, two hospitals, a physical rehabilitation center and nine comprehensive community health programs Offering services across the lifespan including pediatrics, family medicine, nursing, dental, laboratory, radiology, pharmacy, behavioral health, emergency medical, audiology, nutrition, physical therapy and optometry.

DESCRIPTION OF ASSIGNMENT: The purpose of this position is to serve as the PBX operator for the Council Oak Comprehensive Health Center. Incumbent receives and routes all incoming telephone calls to the appropriate department, office, etc. Incumbent also performs cashier duties, maintains transaction records, and receiving payments made to the hospital. Incumbent reports to the Business Office Manager. This position is located at the Council Oak Comprehensive Health in Tulsa, OK.

REQUIREMENTS: Candidates must meet the following requirements:

High School Diploma or GED equivalent is required. One (1) year of relevant experience. It is the policy of MCNDH for all employees to comply with the COVID-19 vaccination program.

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities and personal characteristics, (KSAP's) required of this position. Applicants should address the following KSAP's on a separate attachment to their application.

- 1. Ability to communicate courteously and effectively with Muscogee (Creek) Nation Department of Health (MCNDH) administrative and medical staff, patients and their families, Tribal and Non-Tribal health care professionals and the general public via telephone, and in writing.
- 2. Skill in dealing with many different types of individuals in order to effectively route their calls.
- 3. Ability to react calmly and efficiently under pressure.
- 4. Ability to effectively converse with displeased and possibly unfriendly individuals with composure and tact when needed.
- 5. Knowledge of cash transactions and of the documentation of these transactions for accurate tracking of cash in the system.
