The Muscogee (Creek) Nation Department of Health (MCNDH) provides comprehensive health care services to Native Americans living within the Muscogee (Creek) Nation. MCNDH is an integrated system of six health centers, an Express Care Clinic, two hospitals, a physical rehabilitation center and nine comprehensive community health programs. Offering services across the lifespan including pediatrics, family medicine, nursing, dental, laboratory, radiology, pharmacy, behavioral health, emergency medical, audiology, nutrition, physical therapy and optometry.

DESCRIPTION OF ASSIGNMENT: The purpose of this position is to provide general medical direction, management and supervision of the physician staff of the Muscogee (Creek) Nation Health System (MNHS). Incumbent has responsibility for planning, directing and evaluating a comprehensive health care program consisting of preventive, curative and community health services. The incumbent shall also have overall responsibility for directing medical services within the jurisdiction of the Muscogee (Creek) Nation. This is an Exempt position as applicable to the provisions of the FLSA. Position is located at Council Oak Comprehensive Health in Tulsa, Ok.

REQUIREMENTS: Candidates must meet the following requirements: A Medical Doctor (M.D.) or Doctor of Osteopathy (D.O.) degree is required. A minimum of five (5) years of progressive experience in medical administration is required. **It is the policy of MCNDH for all employees to comply with the COVID-19 vaccination program.**

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities and personal characteristics, (KSAP's) required of this position. Applicants should address the following KSAP's on a separate attachment to their application.

- a) Knowledge of professional medical care administration and management.
- b) Ability to develop and implement medical health care plans, policies and procedures related to patient care services.
- c) Knowledge of professional accrediting requirements, regulations and policies and the ability to implement them to meet accrediting requirements.
- d) Knowledge of community/public health protocols and skill in establishing priorities and determining resource requirements for implementation.
- e) Knowledge of standards of care concerning routine and complex medical conditions including diagnostic, therapeutic and preventive medicine techniques and protocols.
- f) Ability to manage medical programs and supervise the work of others.
- g) Ability to meet and deal in recruiting professional medical care providers.
