The Muscogee (Creek) Nation Department of Health (MCNDH) provides comprehensive health care services to Native Americans living within the Muscogee (Creek) Nation. MCNDH is an integrated system of six health centers, an Express Care Clinic, two hospitals, a physical rehabilitation center and nine comprehensive community health programs Offering services across the lifespan including pediatrics, family medicine, nursing, dental, laboratory, radiology, pharmacy, behavioral health, emergency medical, audiology, nutrition, physical therapy and optometry.

DESCRIPTION OF ASSIGNMENT: The purpose of the position is to provide support and assistance to the pharmacist in the daily operation of the Pharmacy across varying locations. The position will require travel to various sites across the Muscogee (Creek) Nation to work in varying roles to meet the needs of the Department of Health. This position will float to various locations within the MCN Department of Health.

REQUIREMENTS: Candidates must meet the following requirements:
High School Diploma or GED equivalent. One year (1) relevant experience. Incumbent must possess a valid Pharmacy Technician Permit issued by the Oklahoma State Board of Pharmacy or be license eligible. **It is the policy of MCNDH for all employees to comply with the COVID-19 vaccination program.**

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities and personal characteristics, (KSAP's) required of this position. Applicants should address the following KSAP's on a separate attachment to their application.

1. Knowledge of pharmaceutical and medical nomenclature.
2. Ability to utilize a personal computer and its applications in a Windows environment.
3. Skills in organizing and maintaining accurate records and documentation.
4. Ability to maintain strict confidentiality.
5. Ability to communicate courteously and effectively with clinic staff, patients and the general public.
6. Ability to meet and deal with the public for the purpose of supplying or obtaining information.
7. Ability to maintain a confident, professional demeanor.
8. Willingness to travel to meet the needs of the Muscogee (Creek) Nation Department of Health.
