The Muscogee (Creek) Nation Department of Health (MCNDH) provides comprehensive health care services to Native Americans living within the Muscogee (Creek) Nation. MCNDH is an integrated system of six health centers, an Express Care Clinic, three hospitals, a physical rehabilitation center and nine comprehensive community health programs Offering services across the lifespan including pediatrics, family medicine, nursing, dental, laboratory, radiology, pharmacy, behavioral health, emergency medical, audiology, nutrition, physical therapy and optometry.

DESCRIPTION OF ASSIGNMENT: The purpose of the position is to provide administrative management of the Tribal Opioid Response project in grant activities in the health system within the designated service area of the Muscogee (Creek) Nation. Some travel will be required. This position is located at the Council Oak Comprehensive Healthcare in Tulsa, Ok.

REQUIREMENTS: Candidates must meet the following requirements:

A Master's Degree in social work-related field preferred, a Bachelor's Degree, or one year grant experience. A minimum of one (1) year of work experience in pain management, OUD, SUD is preferred. Must possess a valid Oklahoma Driver's License and be insurable. It is the policy of MCNDH for all employees to comply with the COVID-19 vaccination program.

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities and personal characteristics, (KSAP's) required of this position. <u>Applicants should address the following KSAP's on a separate attachment to their application.</u>

- 1. Knowledge of and demonstrated ability to apply management practices and principles related to planning, organizing, staffing, directing, coordinating, allocating resources, and selecting, developing and utilizing subordinate staff in order to achieve established program goals and objectives.
- 2. Proven skill and ability in the areas of treatment, prevention, diagnostics, and consultation.
- 3. Ability to negotiate effectively in a variety of adverse settings and conditions and demonstrated flexibility in dealing with changing priorities or positions.
- 4. Ability to communicate courteously and effectively with patients and their families, MCNDH administrative and medical staff, Tribal and Non-Tribal health care professionals, and the general public both orally and in writing.
- 5. Ability to effectively supervise & motivate staff to achieve program goals and objectives.
