The Muscogee (Creek) Nation Department of Health (MCNDH) provides comprehensive health care services to Native Americans living within the Muscogee (Creek) Nation. MCNDH is an integrated system of six health centers, an Express Care Clinic, three hospitals, a physical rehabilitation center and nine comprehensive community health programs. Offering services across the lifespan including pediatrics, family medicine, nursing, dental, laboratory, radiology, pharmacy, behavioral health, emergency medical, audiology, nutrition, physical therapy and optometry.

DESCRIPTION OF ASSIGNMENT: The purpose of this position is to establish and maintain a Bio-medical equipment program that would provide supervision and direction of all medical equipment activities in the facilities of the Muscogee Creek Nation Health System. Incumbent would be responsible for maintaining a current inventory of all medical equipment and providing ongoing maintenance, repair, documentation, and safety inspections at sites. Other duties would be assigned as needed. This position is located at the Muscogee (Creek) Nation Medical Center in Okmulgee, OK.

REQUIREMENTS: Candidates must meet the following requirements:
Completion of a program/training in BIO-Medical equipment. Technology/Electronic Technology from an accredited technical or engineering school. A minimum of an Associate Degree is required. Five (5) years' relevant experience in Bio-Medical equipment repair. Professional licenses or certifications relevant to this position are required. Must hold a minimum of five (5) certifications relevant to equipment owned by MCNDH. A Valid Driver's license is required.

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities, and personal characteristics, (KSAP's) required of this position. Applicants should address the following KSAP's on a separate attachment to their application.

1. Proficient in Microsoft Word and Excel.
 2. Knowledge in medical equipment repairs and maintenance.
 3. Knowledge of trade practices in electronic equipment.
 4. Knowledge and skill in the preventive maintenance of equipment generally found in hospitals and clinics.
 5. Knowledge of codes and standards applicable to medical equipment set forth by Federal, State, Local and accrediting agencies.
 6. Knowledge and ability to manage the technical and business aspects of the Bio-Medical program such as budgets, contract negotiations, equipment, etc.
 7. Ability to utilize manufacturer's service manuals, schematic drawings and instrumentation to maintain and repair medical equipment.
 8. Ability to use pertinent tools, equipment, and resources to repair and maintain medical equipment.
 9. Ability to communicate courteously and effectively with Muscogee Creek Nation Department of Health (MCNDH) Staff, Tribal and Non-Tribal contractors, governmental agencies, vendors as well as the public, both orally and in writing.
