Muscogee Nation Department of Health (MCN Health) provides comprehensive health care services to Native Americans living within the Muscogee Nation. MCN Health is an integrated system of six health centers, an Express Care Clinic, three hospitals, a physical rehabilitation center and nine comprehensive community health programs. Offering services across the lifespan including pediatrics, family medicine, nursing, dental, laboratory, radiology, pharmacy, behavioral health, emergency medical, audiology, nutrition, physical therapy, and optometry.

DESCRIPTION OF ASSIGNMENT: The purpose of the position is to develop, direct and coordinate Inpatient and Outpatient Physical Therapy, Occupational Therapy, and Speech-Language Pathology. This position is located at the Muscogee (Creek) Nation Council Oak Comprehensive Health Facility in Tulsa, Ok. Incumbent is under direct supervision of the Hospital Administrator. This is a non-exempt position applicable to the provisions of the FLSA.

REQUIREMENTS: Completion of an accredited program for Physical Therapists or Occupational Therapists recognized by the Commission on Accreditation of Physical Therapy or Occupational Therapy Education or approved successor organization. A minimum of five (5) years of relevant rehabilitation experience is required plus two (2) years of supervisory experience is preferred. Incumbent must possess current State of Oklahoma Licensure for Physical Therapist or Occupational Therapist. CPR certification is required.

EVALUATION METHODS: Applicants who meet the requirements described above will be evaluated to determine the extent to which they possess or have the potential to acquire knowledge, skills, abilities, and personal characteristics, (KSAP's) required of this position. Applicants should address the following KSAP's on a separate attachment to their application.

- Ability to develop and monitor quality assurance plans in accordance with pertinent rules, standards, regulations, policies, and procedures as applicable.
- Ability to plan, organize and prioritize work.
